- 12. To receive a report from Department regarding Fire Department activities and operations and act on requests for equipment and expenses for the Department.
- 13. To review and take action on issues related to the District assuming direct provision of emergency services, including actions to employ firefighting staff, and scheduling public meetings on this issue.
- 14. To review and take action on information technology ("IT") matters, including engagement of consultants for the maintenance and improvement of IT infrastructure and resources, District website, digital records and electronic mail.
- 15. To review, discuss and act on the disposition of surplus and/or salvage property.
- 16. To review and act on District/Department PPC/ISO ratings including engagement of consultant(s), review of recommendations and purchase of equipment.
- 17. To receive a report and act on improvements, repairs, maintenance and construction of District facilities, including utilities, construction payments, engagement of architectural or engineering services and selection of contractors.

- 18. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas and Tax Code §323.3022 to discuss sales tax matters.

To meet in Closed Session pursuant to Government Code §551.089 to deliberate regarding security assessments or deployments relating to information resources technology, network security information, or the deployment, or specific occasions for implementation, of security personnel, critical infrastructure, or security devices.
- 22. To review and take action on matters related to lawsuits or claims, including potential settlement of same.
- 23. To review and take action on matters related to the District investigation of District and Department operations, personnel and fiscal matters.
- 24. To review and act on employment/personnel issues, including hiring, retention, compensation, benefits, scheduling, complaints and discipline of District employees, including administrative staff, executive staff and Fire Chief.
